Requirements for Suppliers and Partners; Effective September 1, 2017

Domestic Transportation — Includes USA, Canada Puerto Rico and Mexico

Amphenol Telect values its partnerships with all suppliers and customers worldwide. As such, we have documented a set of guidelines for routing and shipping items to all Amphenol Telect global locations.

All packages on a given day are to be consolidated into one shipment by ship-to address via collect. Penalties may be imposed for failure to comply (see penalties section).

Small Package Ground (1-150 lbs. combined weight)

International Air/Ocean Transportation

All packages on a given day are to be consolidated into one shipment by ship-to address via collect. Penalties may be imposed for failure to comply (see penalty section).

All air shipments should be booked as an economy service shipment (5-7 days). No expedited services are approved unless previously authorized by Amphenol Telect in writing.

Insurance Valuation

Do not insure shipments or declare a value or carrier bill of lading unless authorized by Amphenol Telect. Penalties will be debited from your account if insurance is declared without prior Amphenol Telect authorization.

Packing List, Invoice and Container Instructions

All shipments sent to an Amphenol Telect location are to include a packing list and must follow the container marking instructions listed below.

Commercial invoices are also required on international shipments.

- Shipments routed to Laredo, Texas for Amphenol Telect de Mexico require an invoice and must be included in "pre-alerts" per instructions detailed below
- All packing lists and shipping containers must contain the Amphenol Telect purchase order number, appropriate Amphenol Telect part number(s), part quantity and the content's country of origin
- International shipments also require harmonized tariff number on commercial invoice
- All shipping cartons require carton numbering (1 of X)
- Hard copy packing list must be attached to carton marked #1
- All returns must contain Amphenol Telect assigned RMA number

Pre-alerts are required via email with attached copies of all shipping documents sent to the appropriate email address:

Additional Requirements:

- NAFTA certificate or origin (if applicable) is required for shipments to Laredo, Texas as part of pre-alert shipping documentation
- All shipments containing wood must ship on treated pallets per international solid wood packaging requirements, ISPM 15 (International Standard for Phytosanitary Measures)
- Must be stamped with a standard International Standard Packaging mark (see right)
- All corrugated packaging must meet international shipping standards based on shipping contents



Routing Guide Deviation Penalties

At Amphenol Telect, our relationship with suppliers and customers are our top priority. We respectfully request your understanding regarding the importance of adhering to routing and shipping instructions for Amphenol Telect paid shipments.

The penalties listed below will be imposed to cover additional costs associated with using a non-contracted carrier. Penalty fees are assessed per shipment.

Routing Guide Deviation Penalties	
Issue	Penalty
Utilization of a non-contracted carrier (shipped collect or third-party billing to Amphenol Telect)	Rebill of overcharged freight plus \$100 handling fee
Freight prepaid by shipper and added to invoice sent to Amphenol Telect without prior written approval	Invoice short-paid excluding freight adder
Value declared on carrier bill of lading without prior written authorization by Amphenol Telect, resulting in cargo insurance charges	Rebill of insurance cost plus a \$50 handling fee issued to shipper
Daily shipments not consolidated per ship-to location based on ship method	\$100 handling fee deducted or rebilled to shipper
Shipper does not comply with packing list and container instructions	Additional storage fees and \$50 handling fee deducted or rebilled to shipper
